Superintendent's Report:

Our students brought in 1300 items for the Thanksgiving baskets for Limestone Community High School. Our students also raised over \$3,000 this year for Nets for Vets. That amount will send 6 Veterans on the Honor Flight. In the three years that Limestone Walters has participated, we have raised over \$12,000 in total. We were also presented with a statue in honor of our participation.
